A few questions from our membership:

What is the difference between the 3 mandatory workdays and the sign-ups to volunteer to assist arena/snack bar directors during events?

If these are missed than a \$10 fine will be requested for each missed workday, with a maximum total of \$30/year. Lifetime and honorary members are exempt from this requirement.
